Frequently Asked Questions

Q: What should be included in my sales number?

A: According to the NSSGA Bylaws – Article VIII, Item 2: For the purposes of dues calculations, the entirety of a company's aggregates operations shall be considered – all of a producer's aggregates internal and external sales should be included in the number. Dues are based on that all-inclusive number.

Q: How do I know what my 2021 dues will be?

A: The Board of Directors approved dues formula on the front will allow you to calculate your dues based on your 2020 sales.

Q: Can I pay my 2021 dues with a credit card?

A: Yes. Simply fill out the credit card information on the renewal form for an annual payment and fax it back to our secure fax line at 703-525-7742.

Q: Is the information confidential?

A: All of the information is handled with the utmost attention to security and confidentiality in receiving and storing the data. The information is not accessible to other members, and is never shared with any other entity. We recognize how important this information is to you and we respond accordingly.

Q: When is the deadline and do I have to pay my dues in full?

A: Memberships are billed on a calendar-year basis, therefore covering Jan. 1 – Dec. 31, 2021. Dues can be paid several ways: in full, bi-annually and quarterly.
